All crops (field grown): 1 to 3 l/ha. Apply post-transplanting and during periods of stress or high growth rate. Do not apply at less than 10 to 14 day intervals. Water rate: 200 l/ha.

DIRECTIONS FOR USE

ALWAYS FOLLOW THESE LABEL INSTRUCTIONS
Mix the product thoroughly before use. Slowly add the product to the tank, via the induction hopper, whilst agitating. Top up with water and continue to agitate until spraying is completed.
