Crop	Remarks
Corn	5 l/ha at the 4 to 8 leaf stage. Water rate: 30 to 200 l/ha. Do not spray in slow drying conditions. Alternatively: 2 to 5 l/ha at the 4 to 6 leaf stage. Repeat 10 to 14 days later if necessary. Water rate: 30 to 200 l/ha Alternatively: Apply 3 times at the 4 l/ha rate: 20 days after germination; 30 days after germination; and 45 days after germination. Water rate: 400 l/ha. Seed Dressing: Up to 6 liters per ton. For knapsack sprayer application: 160 ml per 16 liters water (Do not exceed 5 l/ha product per application).
Rice	5 l/ha applied at tillering and at panicle initiation. Repeat application after 7-10 days and again after flowering if necessary. Water rate: 200-400 l/ha. For knapsack sprayer application: 200-400 ml per 16 liters water (Do not exceed 5 l/ha product per application). Seed dressing: 12 liters per ton.

DIRECTIONS FOR USE

ALWAYS FOLLOW THESE LABEL INSTRUCTIONS

Mix the product thoroughly before use. Slowly add the product to the tank, via the induction hopper, whilst agitating. Top up with water and continue to agitate until spraying is completed.
