APPLICATION RATES AND TIMINGS

Almond. Pistachios. Walnuts: 1-2 pints/acre beginning at leaf canopy development 2 weeks after nut set, repeat 14-21 day later if necessary. Additionally, 2-4 pints/acre after harvest before leaf senescence. Water rate: minimum 50 gallons/acre.

Apricot, Nectarines, Peach, Plum: 2-4 pints/acre after harvest before leaf senescence. Water rate: minimum 20 gallons/acre.

Blackberry, Blueberry, Boysen Berry: 1-2 pints/acre as soon as there is sufficient leaf cover to intercept the spray. Repeat two weeks later if required. Water rate: minimum 20 gallons/acre. Not to apply during flowering or fruit development.

Cereals: 1.2 to 4 pints/acre from the 2 leaf stage to second node detectable (Zadok's G.S. 12 to 32). Repeat applications at 10 to 14 day intervals, within this timing, if necessary. Water rate: 5 to 20 gallons/acre.

Citrus, Grapefruit, Lemon, Oranges: 3 to 5 pints/acre applied during spring flush and also during summer / autumn flush. Water rate: 50 to 100 Gallons/acre.

Corn: 1- 2 pints/acre at 4 to 6 leaf stage. Repeat in 14-21 day interval. Water rate: minimum 20 gallons/acre.

Grapes (table). Grapevines: 1 to 2 pints/acre during leaf canopy development pre bloom. Reapply during early fruit sizing at a 10 to 14 day interval and again post-harvest before leaf senescence. Water rate: minimum 20 gallons/acre.

Grapes (wine): 1 to 2 pints/acre during leaf canopy development pre bloom. Reapply during early fruit sizing at a 10 to 14 day interval and again post-harvest before leaf senescence. Water rate: minimum 20 gallons/acre.

Hazelnuts. Pecan: 1-2 pints/acre beginning at leaf canopy development 2 weeks after nut set, repeat 14-21 day later if necessary. Additionally, 2-4 pints/acre after harvest before leaf senescence. Water rate: minimum 50 gallons/acre.

Raspberry, Strawberry: 1-2 pints/acre as soon as there is sufficient leaf cover to intercept the spray. Repeat two weeks later if required. Water rate: minimum 20 gallons/acre. Not to apply during flowering or fruit development.
