APPLICATION RATES AND TIMINGS

Pepper (field grown): apply 1 qt/acre at the start of flowering. Repeat at 10-14 day intervals as necessary.
Water rate: 10-50 gallons/acre.

Potatoes: For increased tuber set apply 1 qt/acre at tuber initiation. To encourage tuber size, apply 1 qt/acre at early tuber bulking (one inch tubers) and repeat at 10-14 day intervals as necessary.
Water rate: 10-50 gallons/acre.

Tomato (field grown): 1 qt/acre at the 4-6 leaf stage. 1-2 quarts/acre during fruit development, repeat in 10-14 days.
Water rate: 10-50 gallons/acre.
